 - a. 2022-23 Enrollment
 - i. 1 student dropped, 2 were added (staff member's children)
 - b. Attendance
 - i. At 94% lower than our usual, but reflects nature of student illnesses nationwide
 - c. 2023-24 Enrollment
 - i. Will be contacting current families for re-enrollment soon
 - ii. Have done several school fairs to do outreach to new families
 - iii. Open House this Saturday 1/27
 - 1. Board members are invited to attend Open House this Saturday or spread the word to friends/family/neighbors
 - 2. Anticipate 50 families will attend
 - iv. Currently 50 new applicants for 2023-24 lottery will be 3/15/23
 - 1. Will contact families within a few days about enrollment status
 - 2. 8 applicants for KG are siblings of current students
 - d. Covid updates
 - i. City Dept of Health has updated recommendations about covid cases
 - 1. Need to review further and discuss w/ staff
 - 2. Possible changes to masking rules based on cases of respiratory illnesses (covid, colds, RSV, flu), not just covid
 - e. School will be up for charter renewal with the state in 2024
 - i. UMSL will formally discuss with us in February
 - 1. No concerns that we won't be recommended for renewal at this time
 - ii. Will need to review and update charter and present what makes us unique
 - iii. Will likely present to State Board of Ed. in October 2023
 - iv. Susan Marino (UMSL) will present at February board meeting on CSIP, MSIP6 and charter renewal
