- 2. Welcome & Opening Comments Sarah, Jay
- 3. Review Consent Agenda Jay, Jamie
 - a. Approved unanimously
- 4. School Related Items Sarah, Eleanor
 - a. 2022-23 Enrollment
 - i. 128 enrolled (lost 1)
 - ii. 92% attendance holding steady
 - b. 2023-24 Enrollment
 - i. Held lottery yesterday
 - ii. 33 applicants placed, 45 applicants on the waiting list
 - iii. Letters went out in mail today will hear back by 4/1/23
 - iv. Will continue accepting applications and considering enrollment through early November 2024
 - v. If we maintain these numbers, we will have 143 students at start of school year
 - 1. Would be highest number ever
 - 2. Will this cause any space/staffing issues? We have the space, but it will be
 - c. Covid Reopening Plan Update
 - i. Review required every 6 months
 - ii. Provided to families, staff, and students (4/5th grade)
 - iii. Will make any needed revisions, then finalize for after spring break
 - d. LEA Updates
 - i. Debbie Hilliard, Sped Coordinator, left in mid-February
 - ii. Hired Melissa (Missy) Sandbothe to replace
 - 1. Retired sped admin from Kirkwood w/ experience in federal programs oversight
 - 2. Came recommended by UMSL sped supervisor
 - iii. As we work to get Missy up-to-speed, we want to officially make Shenika the LEA Supervisor through end of school year
 - 1. Will vote again in July/August to update/confirm roles for 2023-24
 - 2. Approved unanimously
 - e. Review/approve 2023-24 School Calendar
 - i. Changes adding 2 days for parent conferences to allow more space for meeting times
 - ii. State requires 1044 hours. We will offer 1079 hours.
 - iii. Approved unanimously
- 5. Finance Committee Jamie, Sarah

- a. Salary Scale project
- b. Have been working on this for 1 year
- c. 6% standard raise for all teachers, plus half of difference of that raise and where they fall on the salary scale
- d. Will implement fully for 2024-25
- e. Salary scale takes into account years at TSS, how long they've been in the field, education level, certification status
- f. This year's budget for \$1,064, 4444
 - i. Next year's salary budget would be \$1,242,000 for next year, or 13.5% higher, or approx \$175,000 in additional to fund salary increases
- g. Opinion of the finance committee that this partial implementation is a good balance of demonstrating commitment to staff while keeping our budget manageable based on state payment rates and fundraising
- h. Approved unanimously
- i. Will give contracts out tomorrow, and ask for them to be returned by 3/31
- 6. Assessment Data & Academic Landscape Update Shenika
 - a. Academic landscape
 - i. Accomplishments
 - 1. Purchased math and phonics/phonemic awareness curriculum
 - 2. Built out sped staffing/expertise
 - ii. In the works
 - 1. LETRS training science of reading training for teachers
 - 2. Scope & sequence build out working w/ Tad from UMSL
 - iii. Next
 - 1. UMSL working on grant for teaching fellows in ELA/Math who can help lead teacher PD/coaching
 - a. Focus on math & effective co-teaching
 - 2. More focus on utilizing assessment data (STAR)
 - a. Working w/ Bruce for closer look at data
 - i. Will present at staff PD day in April
 - 3. Extra planning time for classroom teachers thanks to Kristen the counselor doing weekly SEL lessons to classes and Sarah Kate doing more Culinary Arts
 - b. MAP data for 2020-21 and 2021-22
 - i. 2022-23 test will be given in April and we'll get scores in fall
 - ii. ELA we are at about 50% proficient/advanced for both years
 - 1. State average was 45% (2021), 43% (2022)
 - 2. SLPS was 18%
 - 3. Soulard was 48% (2021), 49% (2022)
 - iii. Math we are at around 30% proficient/advanced
 - 1. Is area of focus and growth for us
 - 2. Implementation of Investigations Math and additional PD should help address
 - 3. State average was 35% (2021), 39% (2022)
 - 4. TSS 28% (2021), 32% (2022)
 - iv. Science 50-58% proficient/advanced
 - c. STAR
 - i. Have tested twice this year
 - ii. Most grade levels are seeing growth in both math and reading
 - iii. Focus on students identified as "urgent intervention" or "intervention"
 - d. Tiered intervention
 - i. Tier 1 whole class instruction

- ii. Tier 2 kids who need small group remediation a few times a week
- iii. Tier 3 receive daily extra assistance
- iv. Review examples
- e. Student Risk Screening Scale (SRSS)
 - i. Completed by teachers for each student (completed by both teachers in a co-teaching classroom)
 - ii. To identify students with internalizing/externalizing behaviors
 - iii. Not to label or exclude students, but to help assess risk
- f. Q&A
 - i. Are we satisfied w/ data?
 - 1. We are doing well overall, and showing improvement in many areas
 - 2. Want to focus on co-teaching next year to maximize this tool for our academics
 - 3. Still growing in how to use data to affect instruction and learning
 - ii. Do we disadvantage ourselves in math with our curriculum?
 - Tad: Hard to say making assumptions from MAP is tricky because it's just one test. Could be affected by order that we teach - does the test ask something of 3rd graders that we don't teach until 4th?
 - iii. APR was released
 - 1. We are in top 25% for state
- 7. Governance
 - a. Vote to approve updating articles of incorporation to match by-laws. Needed to change the section about what the school closure process will be now that we are a public charter.
 - i. Approved unanimously
- 8. Other Business
 - a. Making good progress on our priorities
 - i. Facilities is another big area to tackle
 - b. Adding new board members and committee members needed too!
